***Facts & conditions***

*These terms and conditions are considered to be carefully taken into account, accepted and understood by the lessee, the booking agent and the customer.*

***Prices:***

***Minimum 3 hours in the archipelago:*** 6,360 SEK / hour (6,000 SEK ex. 6% VAT). Maximum persons 12. Departure and arrival Eriksberg, Gothenburg.

*What's included: 3 crew members, guiding, cocktail snacks, coffee, tea, water, fruit, bath towels, Wi-Fi, diesel, insurances, and harbour fees.*

***Full day, several days and overnight charter:*** Contact us for offer.

***Departure and arrival to/from other harbour than Eriksberg:*** Transport cost will be added.

***Food and beverages:*** Your food and beverages during the cruise are added to the price. See suggested menus under 'Food and beverages' on our homepage. We will contact you in good time prior to your cruise to arrange the menu. The food will be invoiced together with your final payment prior to travel. A separate agreement will be made for payment of drinks ordered during the cruise.

***Number of guests:*** Max 12 guests for days trips and 6 guests for overnight cruises. The ship will not leave if there are more guests on board.

***Safety on board:*** The crew will always start off your cruise with a run through of our safety routines. Life vests and safety rafts are available for all passengers. While onboard our passengers are insured through the company's P & I insurance which complements your usual home or company insurance. The boat is also equipped with all fire safety equipment in line with the Swedish Transport authorities' requirements.

*The captain can terminate the cruise and tell guests to leave the ship if they may endanger themselves other passengers or the crew. No refund can be expected.*

*The planned route can be changed due to weather conditions, security, Swedish laws and no refund can be expected by the customer.*

*All activities the guest participate, is on their own risk.*

***Damage:*** *The customer who booked the cruise is liable to damages on board the ship. If the shipowner has any extraordinary cost for cleaning toilets and the rest of the boat the customer is also liable to these costs.*

***Force majeure:*** *In the event of war, state regulation, strike, blockade, lockout or other work disability, fire, ship failure, accident or other circumstance beyond the control of the shipping company, the shipping company has the right to cancel or otherwise re-arrange the ordered trip without compensation.*

***Permits and certifications:*** *Gothenburg Coast Charter has full licenses to prepare and serve both food and alcohol on board and is fully certified to run a commercial operation.*

***Changes due to weather conditions:*** *We want to ensure that your trip with us gives you the best experience possible and we therefore reserve the right to make changes if necessary.*

*Conditions of booking and payment:*

*The following conditions apply for travel booked longer than six weeks prior to departure:*

- *A deposit of 30% to be paid at the latest 14 days after booking.  
Part cost of the boat hire charge*
- *Full payment to be made at the latest 28 days prior to travel.  
Remaining payment for boat hire and payment of the pre-ordered Food as well as any other pre-arranged activities.*

*For travel booked less than 6 weeks prior to departure the following conditions apply:*

- *Full payment is due at the time of booking.  
Full payment for boat hire and payment of the pre-ordered Food as well as any other pre-arranged activities.*

*Drinks ordered during your cruise will be paid for onboard, prior to docking back in the home harbour. For this payment we accept credit cards.*

*If the payment is not done in time, the booking will be cancelled.*

*Conditions upon cancellation:*

*For cancellations made up to 29 days prior to departure – 30% of the deposit will be refunded.*

*For cancellations made between 8 and 28 days prior to departure - Full refund of the cost of pre- ordered Food as well as 25 % of the boat hire charge.*

*For cancellations made 7 days or less prior to departure – No refund.*

*For changes in the number of guests joining the cruise, up to 8 days prior to departure – full refund of the pre-ordered Food.*
